# JCP AND DIBB CERTIFICATIONS

# **Solution Summary**

The Joint Certification Program (JCP), established in 1985, grants U.S. and Canadian contractors access to unclassified technical data from the Department of Defense (DOD) and Canada's Department of National Defence (DND). It safeguards this data while enabling distribution to qualified entities and ensures eligibility for technical data governed by DOD Directive 5230.25 and Canada's TDCR. JCP certification supports contractors in meeting compliance standards and competing in the government marketplace.
